- Sharon Smith, Council Secretary/Treasurer This TTIP will be allocated for all chapters and Resolutions need to be submitted in order for the Chapter to be considered.
- Judith Shirley, Farm Board Member Are the follow-ups being done? As Chapter Officials, it should be your task to follow-up on these Resolutions that are being passed during Regular Chapter Meetings.
- Alfreda Earle, Chapter Manager TTIP funding requests will be accepted through the end of June 2024 but there is a process where a Proposal has to be submitted with all requests then it is forwarded to the Federal Level for allocation approval. N15 repaving is held due to Historic Preservation not approving due to the Anasazi Remains found. She plead with the Officials to do their part in following up on the Resolutions. The Sunrise Crossing is also a part of the N15 repaving. Ms. Earle also reported that she received a call from a community member yesterday 06/03/24 who reported to her that they busted two tires from the Pot Holes. She asked them to take pictures and send them to the Chapter. Her suggestion to attending Community to take pictures and request a Police Report and the Chapter can pass it on to BIA.

- Patrick Yazzie, Grazing Official suggests that N15 road issues to be added to the next resolution. There are other issues pertaining to stray dogs as well. There used to be a Housing Committee, that should be encouraged to restart by sending letters to the Housing Residents.
