- 1. Honorable Council Delegate Mr. Vince James
 - 11million was approved by NN Council. This Legislation was passed on to OPVP. Resolution 0111-24. 11 million may seem like a lot, but he will be allocated to the five chapters he represents. Looking at the 5 Chapters and the registered voters of 6,000 people can = \$1,800 per person, so building a home for an individual is not possible. His first preference is not to release these funds to the Chapter, so therefore he is thinking of registered individuals.

- Second option is to put this money in trust funds for all 5 chapters so that it can grow interest and distribute every so often.
- He has also asked the OOC if the 11 million can be transferred to Cornfields Chapter for safe holding due to the respect he has for the Chapter and its Manager.
- The fourth Option is to give Apache County District II the 11 Million for purchasing gravel so that all Chapters voters can gravel their driveways.
- Another Option, but not official is purchasing a grader for the Chapter for residential roads.
- OPVP Sexual Harassment investigation is ongoing but no recent update.
- Friday, June 06, 2024 Chief of Police was terminated.
- Director Two weeks ago the Director of DPM was terminated. Executive Director Debbie Nez-Manuel was overstepped by Chief of Staff for OPVP when planning to take the position of Director for DPM.
