#### COMMENT:

- Mr. Morgan Cleveland, Sr. Council President Shared a concern brought to his attention by a staff who would like to remain anonymous in regards to the High School Security Post at entrance. The post currently does not have a restroom for the security staff to use, therefore they have to leave the post unattended when they take a break, the individual asked if the Community can voice to the School Administration that they need a facility.
- Mr. Wallace James, Jr., Council Vice-President responded by stating that the School Board is aware of this issue and they have budgeted funds to improve the Security Post with an indoor facility for School Year 2024-2025.
- 6. Roy Dempsey, Community Relations Outreach Specialist Tsehootsooi Medical Center
  - Provided a Presentation related to diabetes.
  - Appointments are scheduled by an appointment via Mail and a telephone call. TMC kindly asks their patients to inform them they will be unable to keep the scheduled appointment so that you can be rescheduled.
  - If you have more than 1 child being seen, please bring a family member to sit with the child not yet being seen, the nursing staff are unable to watch your child.
  - Appointments are held for 15 minutes, after 15 minutes your appointment will be scheduled.

- TMC Mobile Health Clinic will also add an Elderly Clinic to the Family Practice Clinic therefore the community will have two visits per month.
- Q: When was Sage Memorial Hospital built?
- A: It was reported that Sage Memorial Hospital came into existence in 1930.
- C: It was also announced that Sage Memorial Hospital will no longer have a Walk-In Clinic, therefore an appointment will need to be scheduled. This is also in the works for TMC in the future.

## 7. Tara Benally, Field Director for Rural Utah

- Their non-profit organization has changed many lives in the Utah Navajo communities and would like to continue to do outreach with communities across the Navajo Nation for the people's better understanding of items appearing on the ballot during election.
- Presentation relating to election participation for the National level and they are a non-profit organization.
- They are also non-partisan
- The group will be updating applications for voter registration. The volunteers are willing to answer any questions when completing the application.
- COMMENT:
  - o Judith Shirley understand the party you choose and learn what the party you choose stand for. An audience asked her to read a list of pro and cons for the democratic and republican party. A Point of Order was called by Mr. Wallace James, Jr to state that the pros and cons being shared are each community member's choice and should be shared outside of the Meeting.
- 8. Mrs. Elta Shepherd, Teacher Cornfields Headstart
  - Mr. Bekis reported on behalf of the Cornfields Headstart.
  - The Head Start will be going on a field trip to the Navajo Nation Zoo May 16, 2024
  - Field Day on May 21, 2024 at 12:00 pm
  - Promotion Ceremony/Learning Celebration on May 24, 2024 @ 10:00 am
- 9. Cornfields Veterans Organization Ruthie Nez, Secretary
  - Budget was discussed for their last meeting.
  - They have two more meetings for the remainder of the year; June and August 2024
  - They have budgeted funds allocated for Heating Assistance, Traditional Healing Assistance, and other assistance. The Navajo Nation Veterans Affairs also received 200 applications for Housing Assistance but will only limit 4 per community due to funding.
  - The Veterans Organization had drafted a Resolution requesting the transfer of the Old Ganado Group Home to the Chapter, they had assigned Bennett Dineyazie to bring this Resolution to the Chapter, but they have not received a response of the status.
  - R: Mr. Morgan Cleveland, Sr. responded to the Resolution mentioned in regards to the transfer request of the Old Ganado Group Home to state that the building is owned by Navajo Housing Authority and the Resolution should be addressed with them.
- 10. Cornfields Community Baptist Church Kathy Chee
  - For the Month of June from the 5<sup>th</sup> through the 11<sup>th</sup> they will have missionaries come out from Gulf Port, Mississippi.
  - Would like to Invite the Community to attend their church and Celebrate Recovery activities.
  - Ms. Chee explained that she would like to continue to update the community of the Church activities and remind the community they are all welcome.

#### VII. Old Business:

- 1. Business Report April 2024: Ms. Alfreda Earle, Chapter Manager
  - April Meetings attended the Planning and Chapter Meeting
  - Did not attend the CLUPC Meeting but would like CLUPC to update the Manual
  - The trash bin fills in about 3-4 days. The pulling fee has increased. Once Navajo Sanitation is informed of filled bin, it takes about a week to be changed out.
  - Hay is \$18.02, they recently had a load delivered.
  - Community trash clean-up was held, there were a few volunteers and provided a meal for them on Friday May 10, 2024.
  - Continues to work on ARPA projects and has been keeping her busy daily. April 09, 2024 the renovation staff started. They began assessment and brought back lists of material for each application. They are presently submitting lists for quotations for material. The Chapter staff are receiving calls from community members stating they were not informed of the Renovation and become angry. They are trying their best to explain the process and when the projects were posted for applications.
  - April 18, 2024 Community Food Distribution completed. The next Food Assistance Event will be scheduled for August 2024 and will be the last due to the budgeted amount reaching its allocated limit by then.
  - Septic Cleaning EPA is overseeing this project, the Chapter plotted the homes and submitted names to EPA. She has been following up on the project. Lyle Begay is the main contact person for the Project. Pleads with the community to be patient, EPA should be contacting the individuals for the process explanation.
  - Heating Project The Chapter distributed Propane on Friday based on applications.
    There was 3,000 gallons distributed. They are working on applications with Nation's
    Gas with Residential Tanks, the Chapter Staff will be calling applicants once the delivery is scheduled.
  - Technology Upgrade was completed for the Chapter.
  - \$607,000.00 was received in January 2024 of the \$1.3 million approved for ARPA funds. Of the \$607,000.00 received, 75% needs to be expended in order to receive the remaining amount.
  - March and April expenditure reports for the ARPA funds were submitted and will continue to report monthly.
  - For June planning Summer Youth employment applications will be available toward the end of June.
  - The Chapter Officials candidacy closed Thursday, May 09, 2024. The Candidacy List is available on-line.

  - New Veterinarian Old Double D/Navajo Nation Veterinary Clinic; Will meet him on May 15, 2024.
  - Sun Valley Livestock Auction Now back to every Wednesday.
  - Non-Branded Horse Buying at Window Rock Fair Grounds
  - New Legislation pertaining to the Burial Family Plot. Any future burial will require a land withdrawal.
  - June 2024 Will begin Tally Count for 2024.
  - Q: Homesite Lease Amendments: When will that go into effect.
  - A: He was thinking of inviting someone from Land Administration, but he came across a discrepancy with a constituent. After all the fees were paid by the constituent, land administration declared that one lived outside the chapter boundary. Each Grazing Permit holder needs a Tally count yearly to keep your Permit active, otherwise you will have no say in land issues near you. There are other issues pertaining to Grazing Permit and Farm Land Use Permit.
  - Q: Which Chapter Boundary is the Grazing Office working with?
  - A: The last Official Boundary was documented was in 1970. Then there was another documented boundary by video, but that is considered unofficial by NNDOJ. Cornfields is District 17-03, Ganado is District 17-01, Greasewood Chapter is District 17-02. There is a difference in Boundaries with the Chapter, Grazing and Service.
  - R: Jimmie Taliman, Sr. in 1994 the Chapter Officials and CLUPC went around and reevaluated the Chapter Boundary. There were 2 Chapter boundaries 1 for Branding and the other for Census Boundary. They used a GPS to mark the Cornfields Chapter Boundary and presented it to the Navajo Nation Land Department.
  - A: The NNDOJ suggests that all Official Documents use the Service Boundary instead for services provided.
  - Q: In the years you have served as a Grazing Officer, which holds the most count; by Census, by Permit, or livestock.
  - A: Its all mainly pinpointed by GPS to determine who is receiving a Tally Count.

  - Educating the community on the validity of Land Use Permit for Farming plots. They are supposed to be valid with yearly planting for 2 years.
  - There are a lot of vacant farm plots due to deceased permit holder.
