- b. Tsehotsoii Medical Center Roy Dempsey, Community Relations
  - i. Shared that Tsehotsoii Medical Center has an Interim CEO who stepped down due to complaints of the individual not being Native American. As December 01, 2024 the position has been filled with a new CEO – Dr. Young.
  - ii. TMC is now working on a new care model with a Patient Centered Board. Through the Pandemic, the ER has been treating most patients who come in for urgent care, but there was a concern raised by the ER

- that Primary Care should be seeing patients to alleviate the load from ER.
- iii. Beginning Spring 2025, the walk-in clinic will now serve walk-in clinic. This will also include an on-call 24 hour nurse. The certified individual will be able to assist a patient with an access to healthcare to find the best care needed for the situation.
- iv. Dr. Niomi Young has been working at TMC for over 15 years and has experience with the Patient Centered Home Care Model and is now working on the new Walk-in care model.
- v. COVID has been low presently but with your precautionary measures it should remain low. Rhino-virus is on the rise.
- vi. TMC is also providing Flu vaccinations.
- vii. Cancer the lab tests now cover the respiratory family, cancer and STD screenings.
- viii. Mr. Dempsey will not be able to attend the Regular Meeting on Sunday due to another obligation.
