Mr. Vince James, Honorable Council Delegate – given time to update the attending

UDOT Projects – President Trump has placed a hold on all Federal Highway Projects

TTIP – Cornfields Council Government was approved for funding.

FET – Funding was also approved.

Cost Share of Chapter Projects was also discussed at today's Roads Meeting held for Honorable James' Chapters.

Counties; Apache, Navajo and Coconino will be contacted for discussions for road improvement funding and collaboration.

Allocated amount of \$266,000.00 – Sunrise Low Water Crossing – Plans for the month of April 2025, a 72 inch culvert for temporary placement proposed. The permanent structure will be included with the N15 reconstruction.

Cattle Guards – From Burnside south, the existing cattle guards will be raised higher to prepare for the N15 Reconstruction. A new proposed construction start date is August 2025 for 7.2 miles to begin with.

\$4Million Contract – Wilson & Co and Dibble Construction; Cornfields includes the N15 Reconstruction.

\$248 Million lapse funding will go to other projects not yet identified.

Pot hole maintenance and restriping was discussed at the Roads Meeting today. Honorable James advocated to share the importance of pothole maintenance. Ooverall the roads across the Navajo Nation, N15 has heavy traffic and requires high maintenance.

RRR – Funding to be proposed to be transferred to Cornfields in the amount of 8.8 million for Cornfields to oversee for the five chapters instead of going through the Navajo

Nation Procurement Office. Since funds have been transferred to RRR funding it is considered General Funds for the Navajo Nation.

Discounted Feed – Department of Agriculture is selling Mineral Tubs to grazing permit holders and updated Tally Count for \$40 a tub. Sheep Tubs are available, cow tuns have sold out.

Honorable James dropped a Legislation for \$13 million shortfall for N15 Reconstruction

Dropped Legislation to the 5 member Board of Education

Dropped Legislation for \$3.5 million – Fort Defiance Economic Development

Another Legislation for Lane Filtering for Motorcycle Operators

Navajo Nation Comprehensive Budget was passed by the Navajo Nation Council, now forwarded to the Office of the President of the Navajo Nation.
