Comment: Mr. Jimmie Taliman announced that there is not enough Officials at this meeting, where is Farm Board, CLUPC. As elected Council President, it is your responsibility to make effort in making all these members attend. This is his first time back to attend this meeting.

Response: Mr. Tyrone Chee, Council President responded by stating that he is working with the Chapter Manager and Administration to schedule an orientation with all Committees to get more information on how the meetings should be scheduled.

Update: Honorable Vince James, Council Delegate

- BIA Clarence Tsosie has two staff currently, all other staff have accepted the Retirement Buyout. This might affect the N15 Reconstruction for our community. The last two staff are still deciding whether to accept the Buyout for Retirement.
- The BIA in regards to education is also being affected with limited staff
- As far as he knows, the N15 Reconstruction is still scheduled.
- Projects for Chapters Si has Siin Projects, Internal Projects that Philandra Nelson, LDA compiled will be emailed to Alfreda Earle, Chapter Manager. This list will correlate with the present budget for these Projects. Please double check your listing in case they overlooked for projects. Please follow-up on the projects that have been approved.
- Alberto Chabirer, LDA additional LDA assigned to Honorable James to assist with communicating with Chapters on his behalf.
- There are no items to be added on current Agenda.
- Update on the \$50,000.00 for Farm Board Drought Insurance Honorable James has not found the answer for funds as had been requested by Mrs. Judith Shirley, Farm Board Member.
- Grazing Officials were told to stop Tally Counts. Navajo Nation is planning to take over Grazing Regulations due to BIA being affected by funding and retiring staff.

Grazing Member Update: Mr. Patrick Yazzie

- Dean Gamble and Ray Castillo updated the Permit Holders at the last Permittee Meeting on 05/29/25.
- Ray Castillo covered the fresh brands for livestock sales and the Permit Holders in Probate Status. What is considered a valid Permit; the green documents that have the raised seals. Transfers and Probated Permits in process were issued with a stamp and letter to make it valid, but the Navajo Nation livestock Enforcement Officers raised a concern and sought a legal opinion; now that was deemed unofficial. Now the current rule is that the document has to have an official stamp with an original signature. Jessie Jim – Navajo Nation Department of Agriculture

issued a change for the Tally Counts forward – Each livestock should be described to age and color, etc. The Tally Count deadline was set for June 30, 2025, but was told that this will be extended to a later date. There are several categories of Permits. Total Counted in Cornfields – 124 as of last week: Official Permits 43, Transfers/Probated – 21, Pending with letter of Interest and plan pending – 4, Pending final Probate in court – 23, Not counted – 11 Deceased with no updates – 17.

- He has not been informed of any information pertaining to ceasing Tally Counts.
- Inspections will be given back to the Navajo Nation Livestock Rangers as of 05/30/25. This is under Title III. Rangers are under Department of Fish and Wildlife.
- Nathanial Sam, Ashley Curley, Dean Gamble remain with BIA.
- This AIF coming out was from the 2024 Tally Count. The applicants have started receiving their funds.
- BAR -N- had expired but this was renewed 2016 to 2029 as of current. If you use a state brand, you will not need a Bar -N-.
