#### IV. Announcements/Introduction:

- 1. N15 Reconstruction Update Mr. Darryl Bradley, Principal Civil Engineer NDOT
  - Mr. Darryl Bradley, NDOT Conducted a Presentation, provided written information
  - BIA, Navajo Region had been originally designated to take on the Repaving project for N15, This highway is 21 miles from Burnsides to Greasewood.
  - The repaving project is split into three segments which are now named by phases.
  - Phase I fully funded and presently revisiting the design to begin project Phase I is now 95% complete for assessments to be near Construction Ready.
  - Phase II Middle segment of the three phases.
  - Phase III Has a shortfall of funding in the amount of \$18 million.
  - Phase I is projected to begin construction in April 2026. Most likely this projected start date will Not change due to the increasing costs of design.
  - Mr. Taliman, community member asked how many more times will Archeology will study the identified archeological findings, haven't the findings been completely removed?
  - -Mr. Bradley will reach out to Navajo Nation Historic Preservation to bring to their attention the community questions so that they can schedule a time to explain their process, for a clearer understanding.

- Stock Water price was reduced to .01 per gallon for July and August.
- Hay Chapter plans to have a new load by Wednesday 07/15/25
- Residence Verifications continue to be provided
- Her main focus is on ARPA projects 2 projects remaining
   4 homes on West Sunrise mesa were completed last week
  - 2 more home completed in the Cornfields valley, the Chapter is still encouraging home owners to take on their own repairs to save time for the group of laborers to continue with other homes.
- Reports for ARPA is kept up with and submitted to Window Rock
- Last draw down for ARPA in the amount of \$214,000.00 for the home renovation project
- Summer Youth employment hired 39 students, and last day was Friday 7/11/25
- I.H.S. Safe water drinking program still working with them to provide water and the project for another 2 years
- Partnership for Native Americans assisted Cornfields Community with donations. June 10 and 11<sup>th</sup> they provided 2 shipments of supplies. CHR assisted with the distribution of supplies.

- Windmill water storage tank was delivered on Thursday but it is a temporary tank for Windmill requesting a voter's support to request an immediate repair for a Resolution.

CF- JUL2025-37: Respectfully requesting the Navajo Nation Resource and Development Committee, Navajo Nation Naabik'iyati' Committee, Navajo Nation Office of the President and Vice-President, Navajo Nation Budget and Finance Committee and Division of Economic Development to allocate funding in the amount of \$2,500,000.00 from the Si'hasin Fund to the Cornfields Chapter for Infrastructure Development to support the Deer Point RV Park Project.

Box 478, Ganado, Arizona 86505, and the Community Health Representative & Outreach Program, P.O. Box 1390, Window Rock, Navajo Nation (Arizona) 86515, (hereinafter "CHR/Outreach Program") through end of FY26.

5. **CF-JUL2025-40:** Insisting the Navajo Nation Department of Water Resources to replace a water storage tank for Windmill 17T-522 located on the West Sunrise Mesa due to a leak caused by corrosion at the base of the storage tank in the Cornfields Chapter Community due to an emergency need for the Summer conditions.

6. CF-JUL2025-41: Requesting Cornfields Chapter to assist Dedra Tsosie, Community Member with financial assistance to repair the water line in her home located at Cornfields NHA Housing, which was damaged by a waterline break.

Dedra Tsosie – Addressed the Community Member to request financial assistance for a repair to the pipe connecting to her water heater that affect other pipes under the home, pictures provided in request (SEE ATTACHMENT). \$3792.98 is one quote that was submitted. There were 2 other Vendors she sought a quote from who declined due to no coverage to her location. Ms. Tsosie resides in NHA House #19. The house was obtained through her aunt Orlanda Smith-Hodge and is currently in the process of purchasing the home. In addition to the submitted price qoutations, she would like to report that 3 vendors did not respond, 2 vendors: 1 – from Gallup, NM and 1 – from Winslow, AZ have not respond with a quotation.

Water Heater was replaced when she moved in, She paid \$700.00 to purchase a new water heater, but upon replacement, the pipe attached to the hot water began to leak. Efforts to fix the leak did not suffice to stop the leak. Now, it is recommended that the pipes be replaced.

COMMENT:

Vince James, Honorable Council Delegate – commented to attending quorum, that the Housing Discretionary Funding allocated from the Navajo Nation Government is not allocated to give anyone a hard time when they are requesting assistance.

Norma Noble, Community Member – Would like to comment to identify that there were three vendors contacted. One submitted a Qoute, the two others reported that they do not work on projects on the Navajo Nation. Should this be sufficient?

Ruthie Nez, Community Member – Procurement Process across the Navajo Nation, Federal Government and State Government are almost similar in its process. The submitted Quotation is a Navajo Owned business, a listed vendor with the Navajo Nation Business Regulatory. She is pleading with the community to move forward to vote in favor of this requested resolution.

Cecelia White, Community Member – Commented to state that she has witnessed that the Plumbing Vendors that are available to work with are very limited to our community due to the distance they have to travel.

Vince James, Honorable Council Delegate – Your Chapter Manager, Ms. Alfreda Earle, under the 5-management system and as Cornfields Chapter being a Certified Chapter, the procurement can be managed by the Chapter Manager.

Tyrone Chee, Council President – explained that the Navajo Nation encourages the Procurement Process.

Alfreda Earle, Chapter Manager – Policy for Housing Discretionary Funds for Cornfields Chapter at present is \$500.00. In the past the amount was \$250.00. With the Administrative documentation it requires a homesite lease. The Navajo Nation procurement process requires three quotations. As long as there is documentation of the pending responses, that can be sufficient. Recommendation to the applicant is to work on obtaining a homesite lease to show actual ownership.

7. CF-JUL2025-42: Supporting a Legislation to the 25th Navajo Nation Council for a request of funding the N15 Construction for Phase III with a shortfall of 18.5 million by Vince James, Honorable Council Delegate for Cornfields Chapter.

Honorable Delegate James explained that he is planning to present a Legislation to the 25<sup>th</sup> Navajo Nation Council to request funding to cover a present shortfall for funding the Phase III of the N15 Construction in the amount of \$18.5 Million to aid in completion of the 20+ miles of proposed construction. The attending voting audience is in favor of this said Resolution.

8. CF-JUL2025-43: Supporting the Cornfields Chapter Farm Board in efforts to request their scope of work for their External Contractor Proposal ATTACHED.

M: Ruthie Nez S: Joan Dalgai VOTE: 25 – 0 – 5

Judith Shirley, Farm Board Member explained that the Cornfields Chapter Farm Board has decided that they would like to move forward to making a change in farming for the Community

by hiring Mr. Ed Harvey, a Conservation Planner who is experienced to study the soil to compile statistics that would benefit all future Farmers interested in farming for the Cornfields Community. They have been encouraged to find a useful project to promote and improve Farming in the community by the Navajo Nation Department of Agriculture and this is a result of their planning.

Ruby Lewis – in discussion of current planting field in Cornfields, would this include other fields in the Cornfields Community.

Judith Shirley – Responded to state that this study would be completed at the present Cornfields Irrigation and Farm Plot.

Clarification: To support the Farm Board, in recommending to hire Ed Harvey, Conservation Planner using the \$50,000.00 with the Department of Agriculture.

Tyrone – Do you have a supporting resolution passed by the Farm Board, this Resolution would serve as a support to move forward to hire Mr. Ed Harvey with the Navajo Nation Department of Agriculture.

Judith Shirley - Responded that Nathaniel Sam, encouraged the Farm Board to move forward with a plan to show that this can be a use for the \$50,000.00 Drought Insurance Funding that the Department of Agriculture is holding.

Ruthie Nez, Farm Board Member – explained the Resolution request in the Navajo Language.

- Reported that he will be participating in a Trail Ride from Ganado Chapter to Window Rock Fair Grounds on Sunday, July 20, 2025.
- Zenni Homes was awarded \$24 Million to fund manufactured homes, but reported as of Friday 7/11/25 that they will be closing their doors on 7/14/25. This resulted in a Legislation 0175-25 being submitted by Honorable Council Delegate Shandiin Parish for investigatory procedures on ZenniHomes and Indigenous Design Studio.
- The Controller of the Navajo Nation McCabe submitted a Letter of Resignation and emailed Honorable Delegate James and others on Friday July 11, 2025 and reported that he had his letter acknowledged by President Nygren. But when Legislation 0174-25 was dropped, he rescinded his letter and states he will return to work on 07/14/25 at 8:00am.
- Division of Family Services announced that they have unspent funding for the Navajo School Clothing and are encouraging all Navajo Parents who did not apply to submit their applications. If there are any questions, reach Thomas Cody, Executive Director for Navajo Nation Division of Child and Family Services at (720)207-7696.
- Child Care Center in Greasewood closed and will be reopening in Ganado.
- Ganado Navajo Housing Authority is currently talking with the Navajo Division of Children and Family Services about leasing the vacated Annie Wauneka Life Care Center and the Cornfields Group Home as a Youth Home for the Navajo Nation. Other businesses also had interest such as Sage Memorial Hospital and Chinle Nursing Home, but they have not made a final decision to move forward with their plans.

Would like to invite Dean Gamble to provide a presentation for the Permittee Meeting this month and will schedule his meeting based on Mr. Gamble's availability.

Mohair and Wool Sale in Window Rock scheduled at the Fair Grounds in Window Rock, AZ on July 29<sup>th</sup> through the 31<sup>st</sup>.

Windmills in the community still have water in the Community.

Department of Agriculture has put the Feral Horse Round-up on hold. The Ranch hands that assist the Department of Agriculture, are not being paid. The buyer for the Feral Horse disagreed for favoring one vendor, so the BIA looked back into the protocols of the hiring of ranch hands and procuring the vendors as buyers. The funding received in purchasing the Feral Horses returns the funds to the Navajo Nation General Funds.

Branch of Natural Resources under the BIA, Dean Gamble and two others Ashley Curley and Nathaniel Sam work under Mr. Gamble. Mr. Sam works closely with Farm Board.

Thursday – July 10, 2025 – stopped at Department of Agriculture to inquire what documents are required for selling wool and mohair. Bill of Sale needs to be provided, this is being negotiated. For Permits that pending the final decree of transfer and probated permits, they would be able to sell their wool and mohair. If you have a permit and have not yet taken it into court, a letter of recommendation is required.

Range Land Technicians will be hired (7 chapters) as FTE. There will be a Range Land Technician hired for chapters covered by Council Delegate. Each Range Land Technician will have their own vehicle assigned to carry out their tasks.
