- Mr. Victor Dee, El Paso Natural Gas (EPNG), Kinder Morgan
 - The El Paso Natural Gas Pipeline and its Right of Way of the existing pipeline is due for renewal..
 - The existing pipeline continues to operate and this renewal request is not requesting any additional structures to be added.
 - Curtis Yazzie, Operations Supervisor with Kinder Morgan. He oversees the monitoring of the Pipeline from Tohatchi, NM to Navajo Station south of Cornfields Chapter.
 - Arvis Francisco, Pipeline monitoring personnel with Kinder Morgan, also monitors the pipeline activity from St. Micheals to Navajo Station.
 - This ROW renewal is being requested from the Navajo Nation Minerals Department.
 - There are many retirees from EPNG.
 - This Resolution for the Renewal of the ROW being requested is for 20 years.
 - Audience questioned the age of the pipelines and current operations in monitoring:
 - Mr. Yazzie explained the routine inspection of the pipeline and use of Technological equipment such a Smart PIG, Cathodic protection coating placement. They will be conducting a new test from Tohatchi to Navajo Station next month by sending a Smart Pig through their pipeline.
 - Dana Eldridge, Community Member posed a question on Emissions: Are there any exposure of gases like Methane that are harmful to residences who are living along the pipeline? When they release the pressure from the pipeline every so often, they can smell fumes.
 - Curtis Yazzie answered the Question: The fumes that are released are nothing more than what a human inhales from daily emissions from the surrounding environment. The release is recorded and monitored by Kinder Morgan which is then reported to the Federal level. During a blow-down procedure (procedure involving removal of gases for a pipeline repair), there are procedures that need to be taken where equipment are brought in to release the excess gases into during repair.
 - The pipeline is the safest form of transporting Natural Gases today other than railroad, trucking, etc.
 - Ms. Eldridge: Responded to the response given to state the question involving how much gas that is being released during pressure relief is emitted and if the level of gas released is within the approved limits from a Federal Standpoint. Then to further elaborate on how often pressure is released, by how many times per month and total amounts per month.
 - Ms. Victoria Begay, community member also resides near the pipeline who reported that she currently holds a position in working with Right of Ways across the Navajo Nation and asked if the ROW works with the Fish and Wildlife Department and if they issued a clearance for the current pipeline.
 - Question: How much Royalty is the Navajo Nation receiving per month, per year?
 - Explanation/Clarification: Mrs. Irene Aldrige, Community Member. This Pipeline was originally approved by our elders three generations back, but it is not known what vocabulary was included in the original agreement. There are concerns today that were not brought up during the initial pipeline construction due to the lack of education, now our children bring these concerns forward based on what they have studied in regards to the environment and our health.

- Stanley Benally, Community Member added that when Mr. Dee came before the Planning Meeting recently, there were others who had mentioned the El Paso Navajo Station Road and the request for maintenance to improve the existing road. At that time Mr. Dee stated that he would ask the Company about this request and if it could be included with the renewal of the lease? What information was obtained from this inquiry?
- The Questions were not clearly answered.
- o Elizabeth Johnson, Community Member made a motion to move forward on the Agenda.
- Warren Thomas, Apache County District II Clarified that the El Paso Natural Gas Road is now Kinder Morgan Road. The Road that Apache County covers for maintenance, extends from Cornfields Chapter to the Old Navajo Station Air Strip. If the residents from South Navajo Station propose a Resolution to request N9205 to be transferred to Apache County, that could be considered.

Elizabeth Johnson, Community Member – Requested Clarification of Reaffirming or submitting a Resolution in addition to the Original Resolution, what was the reason that the Original Resolution was not considered?

Sharon Smith, Council Secretary/Treasurer - As understood by the report given by our Council Delegate during the Planning Meeting, the request involved obtaining the approval of three chapters; Klagetoh, Cornfields and Greasewood Springs and due to jurisdictional issues, the request was not forwarded for funding. His suggestion to Mr. Benally entailed that the Resolution be addressed to Indian Health Services due the request for this waterline being mainly for the purpose of health related reasons and to mitigate the ongoing COVID-19 virus.

Stanley Benally, Community Member – addressed the reason for this request as he continues to advocate for the residence residing South of Navajo Station. After the initial request for this waterline extension there was a collaboration between Indian Health Services and Navajo Engineering Construction Authority who placed Cistern Systems at some residences, but the cistern system have some issues:

• Hauling water is a heavy task, especially for the elderly when filling the water storage tanks.

- The water that comes from the constructed pipes have oil and there is no way to clean out the tanks that store the water.
- The cistern system runs off of an electric water pump, which does not function during a power outage.

Stanley Benally – Community Member – Pleads with the Officials to continue advocating on their behalf for this waterline extension.

Mr. Larry Yazzie – Community Member – Stated that his daughter informed them of her installed Cistern System, but he was never approached or asked if he needed one for his home.
