- Thanked Mr. Tyrone Chee and his family for providing a meal for today's meeting
- Services continue to be provided daily.
- The Chapter will be closing the livestock water soon.
- The Chapter purchased two additional washing machines that were finished being installed last week.
- The Chapter received a new load of hay and the price will be \$17.49 per bale (price includes tax)
- APRA reporting continues. The ARPA Home Improvement workers completed two more homes. All reports are submitted monthly and they are up to date in their reporting.

- ARPA Home Improvement Funding Two draw-downs were successfully received since the original award. The remaining amount \$217,000.00 was requested in July, the Chapter is still waiting for the funds to be received. Due to delayed replenishment of fundind, the workers were laid off as of Friday October 03, 2025. It is becoming difficult in working with the Navajo Nation APRA Program due to constant turnover.
- Met with CPMD Michelle, regarding transferring Sihasiin Funds for the proposed Projects.
- ASC Meeting on FY 2026 budget. Funding was not available in the WIND system. The following week
  there was an amount shared via spreadsheet but they were advised not to share the amounts until
  the amounts were posted in the WIND System.
- The Chapter will be awaiting to receive the remaining ARPA fundings and the Sihasiin Project funds
- Auditor General performed an Audit on September 12, 2025. They were scheduled in the afternoon, but he showed up in the morning. All files that were requested were provided. They will be providing a written report pertaining to the Audit performed and will be shared once available.
   Question:
- Norma Noble what is the status of the Septic Tank Cleaning?
- Response:
- This was a funding was moved under the ARPA Funding and was transferred to the RRR. Ms. Earl will submit an email inquiry.
- Dickie Smith Has two questions or proposals for the Chapter:
  - What became of the stolen property the UTV.
  - o The Community Corral located next to the Windmill West of the Chapter needs to be renovated, the Chapter should make it a project to rebuild it.

#### Response:

- O UTV Update: Ms. Earle retold the incident of property stolen from the Chapter that was stored in the Chapter Barn. An unknown individual(s) took 5 gallon gas tanks, a paint spray machine and big drill. The spray machine was recovered outside the main chapter fence. The Chapter replaced the padlocks. The next day there was another break-in when they stole the UTV. They attempted to cut the padlocks that were replaced the day before. After investigations were carried out by the staff, they noticed the padlocks were marked as they were attempted to be cut, so they used a vehicle to pull off the gate. The police were notified and it was reported stolen. The UTV was then reported to have been seen in Gallup, NM in the Gamerco area. The Gallup Police Department is aware. An insurance claim was filed recently with the Navajo Nation Risk Management Office, but this is pending a Police report still yet to be received.
- O Chapter SUV Damaged last month by dogs chasing either a cat or squirrel into the Engine Compartment and during this event, the dogs tore of the lining of the wheel well and might have tore some wiring in the process, the vehicle is inoperable and still awaiting a Police Report.
