3. **CF-JAN2026-15:** Expressing support for the request by Navajo Health Foundation – Sage Memorial Hospital, Inc. (“SMH”) to have the Navajo Nation transfer the land leases for two vacant assisted living facilities currently held by Navajo Housing Authority, commonly known as the Cornfields Group Home and the Ganado Assisted Living Center

Ms. Dixie Barlow, Community Liaison – Sage Memorial Hospital presented the Resolution.

Mr. Jerom Prows, Facility Manager – Sage Memorial Hospital assisted with Questions.

QUESTION(S):

- What population will be assisted?
- When does SMH estimate to open their facility?
- Further questions and discussion pertaining to this lease transfer which led to question,

RESPONSE:

- SMH has not done a complete needs assessment. But the Facility in Cornfields will be directed toward Adolescent Services. The Ganado Assisted Living Center will be for Adult Day Care or Respite Care Services.
- There was vandalism of the building with copper wiring and tubing being removed which has to be renovated and repaired so the operation expectancy is for 2027.

COMMENT:

- Explanation of Lease Transfer by Honorable Vince James, Council Delegate – once the Chapter Constituents vote to approve this Resolution, Sage Memorial will apply for a Lease of its own for their Business, someone needs to ask how the Community of Cornfields can benefit from their new business. Also know that once this facility opens, Sage Memorial Hospital will open up to having their patients come to Cornfields Community, the community should be asking how the community could best be served with priority.
- Further discussion revealed that Cornfields Chapter is the Lease Holder for all businesses on its compound, A Letter of Intent was shared, written in 2017 by the Late Justin Johnson, Council President. There is also a response on file as received from the Land Administration granting the Letter of Intent which names all buildings on its current Land Lease.

RECOMMENDATION:

- To table this Resolution, to get clarification to better collaborate services for the community. Tabling the Resolution will be up to the Next Chapter Meeting in February.
